#### About - Rural Organization for Social Advancement

Rural Organization for Social Advancement, known as "ROSA", is a social organization registered in Varanasi, Uttar Pradesh. This organization is providing services to the needy, poor and helpless individuals, families and communities of the society as per its objectives.

This organization came into existence in 2003 and is registered under the Society Registration Act 21, 1860.

"ROSA" was founded by a group of experienced social workers who had been working for a long time in various districts of Uttar Pradesh. It all started with a decision to share their work experiences, working strategy, dedication towards public interest and future dreams as a collective knowledge, understanding and collective efforts. With time, people with similar understanding and ideology joined in and the scope of the work grew.

### 1- Support in Health and Nutrition, Chakia, Chandauli

The effects of Covid-19 last year have had an impact this year as well. On the basis of



the guidelines of the state government, sometimes there was relaxation in the lockdown and sometimes up to some limits. Taking initiative on the issue of health and nutrition in Chakia, development block of district Chandauli, with the help of CRY, the organization took intensive initiative in

## 4- Emergency support (COVID-19)



The livelihood resources of 1620 identified families of district Azamgarh were affected due to the effects of Covid-19. Due to which those families were facing difficulties in meeting their day-to-day needs. Even after wishing, they were not able to get daily wages or income generation work. Due to the circumstances of the lockdown in big cities, the factories had not started relatively yet. Due to which the needy were unable to get a livelihood by migrating. During this time the schools were also closed due to which the mid-day meal was not available during the day. Such concerns were expressed by people at community meetings.

Due to all these circumstances TFF decided to send 1000 rupees per family to the identified 1620 families in their bank accounts. The biggest challenge in helping people was to get the correct bank account details. Because at this time also there was a lock down and there was an effect of Covid-19 and due to the merger of the bank, the code of fund transfer had changed. The project team accepted the challenge and made a list of back details of 1620 identified people.

After talking to the bank details, the organization sent one thousand rupees to the identified needy each family through the bank. A total assistance of Rs 16,20,000.00 was provided.

### 5- Mata Sabri Poshan kitchen

Musahar community in Uttar Pradesh is one of the poorest of the poor communities in



India. Due to their identity, historically the community had been relegated to living in forest areas and catching rats for livelihood and were often denied any other work or source of income. Sheer deprivation historically had led to the community surviving on a subsistence diet of rats and

other rodents, which is where the name 'Musahar' stems from. Due to the rampant stigma and discrimination present even today, the community, living in various hamlets across eastern Uttar Pradesh, are still victims of abject poverty and destitution. ROSA has been



working with Musahar communities in various districts of eastern Uttar Pradesh for over two decades now. One of the most heart-breaking observations that ROSA has had over the years is the high rate of child mortality within the Musahar community. A vast majority of the children below five years are severely malnourished and often leading to devastating outcomes.

"The Musahar community lives in small ha mlets outside of main village in forest-fringe areas. Government schools, Anganwadi centers are often not accessible to the community. The parents usually remain out of the house for the whole day, collecting forest resources or working in other people's land. The children get hungry around midday but they are forced to go hungry.

ROSA has initiated community kitchens 01 Musahar hamlets (Talra). The community kitchen will be equipped with dry grains food items for 18 children. One volunteer from the community, each day, will be assigned the responsibility of providing the children a meal at midday when they are hungry.

The organization worked regularly towards social advancement during the reporting period. The organization's workers, volunteers, auspicious thinkers, donor organizations and individual's donor contributed immensely to this pious work. Because of which so much was done. All this was possible under the efficient guidance of the General Assembly and Executive Committee of the organization. We thank all those who have directly or indirectly contributed to the social work of the organization.
